We refer to the Rules, Procedures & Financial Disclosure Documents for the Leadership Election Process of the Progressive Conservative Association of Alberta dated Friday, June 17, 2011 (the “Rules”) and pursuant to same, we now attach an Audited Financial Statement, as defined in the Rules, on behalf of Frederick L. Morton, who participated in the Leadership Election Process.

As provided for in the Rules, the Audited Financial Statement is to contain and/or set out the following:

- Income and expenses in accordance with section 7(2) of the Rules;
- The amount of any transfers;
- A statement describing how surplus funds, if any, will be expended;
- The record of Contributions as required in section 11 of the Rules, and
- The information required in Section 14 of the Rules.

We note that the Audited Financial Statement has been audited by MNP LLP, a national firm of chartered accountants. We also note that the only transfers made by the Friends of Ted Morton Campaign (“FOTM Campaign”), which was the funding organization for Frederick L. Morton, were made from the FOTM Campaign PayPal account which was used for online donations, to the FOTM Campaign bank account with FirstCalgary Financial. Further, we note that there were no guarantees of any nature, as referred to in Section 14 of the Rules, made with respect to the candidate or the FOTM Campaign.

In addition to the disclosure in the Audited Financial Statement with respect to Contributions, there are two attachments to the Audited Financial Statement that provide additional information with respect to such Contributions. The first attachment contains a listing of all donors (including those whose donations did not exceed \$375.00) who made donations directly to the FOTM Campaign by check or by credit card. This list of donors includes the name of the donor, the address of the donor, if available, the amount of the donation, and the date of the donation. The second attachment contains a list of donors whose donations exceeded \$375.00 but who made these donations using the FOTM Campaign PayPal account, which as mentioned above, was the online account accessed through Dr. Morton's campaign website. Donations made online did not include an address and as such the second attachment contains only the name of the donor, the amount of the donation and the date of the donation. The second attachment sets forth only donations made on the FOTM Campaign PayPal account that exceeded \$375.00.

The Audited Financial Statement indicates there are surplus funds of approximately \$116,000. As set forth in the Audited Financial Statement, it is the intention of the FOTM Campaign to donate these funds, to the Glenbow Ranch Foundation and The University of Calgary, Political Science Department for a scholarship fund for graduate students involved in Canadian Constitutional Studies.

As provided for in the Rules, it is our understanding that a candidate has a period of up to six months from the filing date of February 1, 2012 filing to disburse the surplus funds as provided for above.

We look forward to receiving the refund of \$15,000 from Dr. Morton's \$40,000 deposit and request that it be made out to the Friends of Ted Morton and sent to my attention at Sierra Energy Inc., Suite 1200, 707 – 7<sup>th</sup> Avenue S. W., Calgary, Alberta T2P 3H6. Alternately, please contact me when the refund is available and we will have it picked up.

We trust the foregoing and attached are in order and meet the requirements contained in the Rules. ## Independent Auditors' Report

To the Progressive Conservative Association of Alberta:

We have audited the financial statement of Friends of Ted Morton ("the Campaign") for the period ended November 30, 2011, which comprises the statement of revenue and expenditures and other explanatory information. This financial statement has been prepared in accordance with the reporting requirements specified in the Candidate Rules, Procedures & Financial Disclosure Documents for the Leadership Election Process of the Progressive Conservative Association of Alberta dated June 17, 2011.

### *Management's Responsibility for the Financial Statement*

Management is responsible for the preparation and fair presentation of this financial statement in accordance with the Campaign's reporting requirements, and for such internal control as management determines is necessary to enable the preparation of the financial statement that is free from material misstatement, whether due to fraud or error.

### *Auditors' Responsibility*

Our responsibility is to express an opinion on this financial statement based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statement is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statement. The procedures selected depend on the auditors' judgment, including the assessment of the risks of material misstatement of the financial statement, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statement in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statement.

We believe that the audit evidence we have obtained in our audit is sufficient and appropriate to provide a basis for our audit opinion.

### *Opinion*

In our opinion, the financial statement of Friends of Ted Morton complies in all significant respects with the reporting requirements stated above for the period ended November 30, 2011.

### *Basis of Accounting and Restriction on Distribution and Use*

The financial statement is prepared to assist Friends of Ted Morton in complying with the financial requirements provisions of the document referred to above. As a result, the financial statement may not be suitable for another purpose. Our report is intended solely for Friends of Ted Morton and the Progressive Conservative Association of Alberta and should not be distributed to or used by parties other than Friends of Ted Morton or the Progressive Conservative Association of Alberta.

**1. Incorporation and operations**

Friends of Ted Morton ("the Campaign") was founded to facilitate the collection of donations and control of expenses to fund the leadership campaign of Dr. Ted Morton for the Progressive Conservative Association of Alberta.

**2. Significant accounting policies**

The financial statement has been prepared in accordance with the reporting requirements specified in the Candidate Rules, Procedures & Financial Disclosure Documents for the Leadership Election Process of the Progressive Conservative Association of Alberta dated June 17, 2011.

***Revenue recognition***

The Campaign recognizes revenue as donations are received or if collection of pledges is reasonably assured. Membership sales were recognized when payment was received.

**3. Excess cash on hand**

The Campaign will donate all revenue received in excess of all current and future liabilities to the Glenbow Ranch Foundation and the University of Calgary, Political Science Department to fund a scholarship program for graduate students involved in Canadian Constitutional Studies.
